- 3. Payments can be paid by bank transfer sort code **20-63-28** Account no **30093874** / by debit card by phoning the office.
- 4. An inventory will be issued and agreed at tenancy commencement. Students and their guarantors will be responsible for any charges incurring towards repairing damage, cleaning required at tenancy end or redecoration, removal of debris to the landlords property and the associated administration charges. The property will be assessed at tenancy end using the agreed inventory.

 - a.) The owner agrees that, subject to your satisfying the normal selection procedures employed by Student Living (Nottingham) Limited, he will grant you an Assured Shorthold Tenancy.
 - b.) Student Living (Nottingham) Limited reserves the right to withdraw any application that does not satisfy the normal selection process employed by Student Living (Nottingham) Limited and the Holding Fee of the first weeks rent will be refunded to you without delay.
 - b.1) For any tenants that drop out of the tenancy it is their responsibility to find a suitable tenant which is accepted by all occupants of the property and the Landlord. We also reserve the right to keep any monies paid by the drop out tenant until the new suitable tenant application process has been completed and has signed the tenancy agreement however the holding fee is non-refundable to cover the administration cost.
 - c.) The owner agrees that provided the terms for such agreement is agreed between the parties and contracts completed by the commencement of tenancy he will allow you to take occupation without hindrance, subject only to the payment of the agreed first month rent, & any paperwork has been completed by ALL OCCUPANTS, before occupation takes place.
 - d.) You warrant that should you fail to take up the agreement and occupation of the specified property/room other than finding a new suitable tenant as described in point b1., you will forfeit any monies paid and are liable to pay the full academic years rent.

Please sign, date this application form and pay the remaining Holding fee (one month's rent) On receipt we shall immediately ensure that the property/room is withdrawn from the Lettings Market subject to the clauses referred to above.
